# A Message from Kenya Campbell President, AFT Maryland



Welcome to the 2024 AFT Maryland Triennial Constitutional Convention!

This is our first time gathering in person since 2018 and I am excited to be in-person with delegates and local leaders once again. A lot has happened since we last met, including the state federation relocating to a new headquarters. It is my immense pleasure to welcome everyone to the AFT Maryland offices for this occasion. It is our hope this office is a hub for labor and the community as we work to fulfill the promise of a reimagined world that serves us all. Just as the office symbolizes turning over a new leaf for the state federation, much of our work the last three years has been about creating a world that delivers Real Solutions for Maryland Labor and Communities.

Our state federation has expanded to include community college faculty from institutions across Maryland who have decided the best way to have a voice at their colleges is unionization. Education professionals at the Maryland School for the Deaf have worked tirelessly to secure collective bargaining and unionization, and since we last met, they've agreed to and ratified their first ever union contract with their institution. In choosing a union, these workers have decided that AFT Maryland is where they want to be, because we are the union for Maryland professionals.

In addition to expanding, our state federation has also continued to lead the way advocating for healthcare, education, and public service professionals that make up AFT Maryland. When efforts across the nation attempted to ban books, we put thousands of books into the hands of Baltimore city school students to create and expand their home libraries and love of learning. We conducted unprecedented steward training for public employees to empower our members to be change agents at their worksite. We also expanded our footprint in the communities we live and work.

AFT Maryland is on the move. We have done a lot of work, and yet much more work remains. It is my hope that at this convention you'll be informed and energized by all we are doing in the labor movement and you take this momentum back to your colleagues and bring more of them off the sidelines to help us. Labor is alive and well, and with your help, we hope to make the state feel our power.

I am proud to report that the fiscal state of AFT Maryland presents fairly.

Over the last three years, AFT Maryland continues our diligent work as responsible financial stewards of the resources of the state federation. I am pleased to report that we are meeting our financial responsibilities while continuing to build our organization. There have been several ways we have been able to benefit members and locals with the resources we have. Following is a brief example of some of the work we have done.



Many of our locals were able to receive a rebate. Additionally, we've grown the state federation in meaningful ways with the addition of locals based on community college campuses across Maryland. With the hiring of new organizers for this campaign, that harvest continues to bear fruit. As you know from the location of this year's convention, we outgrew our former office space and moved into a larger facility that serves as not only as an office, but a headquarters for AFT Maryland and all of our local affiliates. This location has already been used by locals for steward training, and by the AFL-CIO as a hub for Get Out the Vote efforts supporting labor-endorsed candidates.

Beyond the physical growth of the state federation, I have been privileged as the Secretary-Treasurer to participate in the professional growth of the organization. Following a historic vote to unionize at the Maryland School for the Deaf, we helped negotiate the first contract in that school's history. The state federation is currently in bargaining at three community colleges, and I have the pleasure of serving on the bargaining team for negotiations with Frederick Community College.

AFT Maryland has grown in meeting the needs of the community. At a time when book bans are far too frequent across the country, we have been active in participating in AFT's Reading Opens the World campaign, distributing thousands of books to young people and families in Baltimore City schools and across the Baltimore region. This is just an example of our stewardship of AFT Maryland resources.

Finally, our auditors have reviewed our finances and determined our records to be up to date and financially sound.

Our agenda today includes a full and comprehensive summary of our financial status for delegates to review. Again, welcome to the state federation's new home and enjoy the 2024 AFT Maryland Convention.

#### Dear AFT-Maryland Officers and Members,

I am so sorry I will not be with you in person for the 2024 AFT-Maryland Triennial State Convention, but I wanted to spend a moment honoring you and the work you do. You have so much to commemorate and celebrate since you last met in 2021. You have always been committed to the well-being of your communities, but it's never been truer than during this period of recovery from a devastating pandemic. Following more than one unprecedented year when you had to turn on a dime and work harder than ever, you turned again to facilitate a period of healing. I am so proud of the dedication, creativity and compassion you've shown. For together we can accomplish what is impossible to do alone.

AFT-Maryland is made up of members and leaders who make a difference every day in the lives of others. Last year, AFT-Maryland educators marked historic organizing wins in K-12, with 99 percent of the faculty and staff at the Maryland School for the Deaf voting to unionize, and in higher education, with five community schools joining our ranks. The AFT is now the fastest-growing higher education union in the country.

AFT-Maryland first responders and healthcare professionals are still on the frontlines of our recovery, and AFT-Maryland state and local employees, through the City Union of Baltimore, successfully campaigned to have several workers moved to safer locations to protect them from hazardous conditions. And you all contributed to the successful election of Gov. Wes Moore, who signed a three-year labor contract not only with the AFT, but with AFSCME and the Maryland Professional Employees Council.

Now we have another challenge ahead of us: At a time when we need to come together, our country is dangerously divided. We are in the midst of an onslaught of polarized attacks on our freedoms and our values. The labor movement is being targeted by corporations that only care about their bottom line, and politicians who don't believe in rewarding work, just wealth. We have seen this before. Political extremists fear the progress that is possible when individuals come together—that is why we are seeing legislatures around the country passing laws to limit worker voice and make it harder for people to join unions. And then there are the culture wars—the banning of books and censoring of history.

The American Federation of Teachers is a union of professionals that champions fairness; democracy; economic opportunity; and high-quality public education, healthcare and public services for our students, their families and our communities. We are committed to advancing these principles through community engagement, organizing, collective bargaining and political activism, and especially through the work our members do.

# Proposed Standing Rules AFT Maryland 2024 Convention Rules

- **Rule 1.** Before a delegate is granted the floor, he/she shall be recognized by the Chair, and before expressing his/her views, shall make known his/her name and the local he/she represents.
- **Rule 2.** No question shall be subject to debate until it has been made, seconded and stated from the Chair.
- **Rule 3.** If a delegate is called to order while speaking, he/she shall, at the request of the Chair, take his/her seat until the question of order is decided.
- **Rule 4.** Should two or more delegates rise to speak at the same time, the Chair shall decide which one is entitled to the floor.
- **Rule 5.** No delegate shall interrupt another in his/her remarks, except to rise to a point of privilege. The Chair shall determine whether the point raised is a question of privilege.
- **Rule 6.** Speeches on matters of business shall be limited to three minutes, but the time may be extended by a majority vote of the delegates present and voting.
- **Rule 7.** A delegate may not speak a second time upon the same question until all delegates wishing to speak have had the opportunity to do so.
- **Rule 8.** Debate on any item of business brought before the Convention shall be limited to thirty (30) minutes unless otherwise extended by majority vote of the delegates present and voting.
- **Rule 9.** Robert's Rules of Order, Newly Revised (12th Edition) shall be the guide in all cases in which it is applicable.
- **Rule 10.** Delegate badge/credential is required to gain entry to the delegate floor. A delegate/ guest badge is required to gain entry to the convention hall.



# Parliamentary Motions Overview

#### Things You May Do When Another Member Has the Floor

- 1. Rise to a point of order, point of information, or question of privilege.
- 2. Object to the consideration of the question.
- 3. Move to reconsider.
- 4. Appeal.

#### Motions That Cannot Be Amended

- 1. To adjourn (if the motion is to adjourn at a particular time it can be amended).
- 2. To table, or to take from the table.
- 3. To reconsider.
- 4. To call for the previous question.
- 5. To suspend the rules.
- 6. To object to the consideration of the question.
- 7. To postpone indefinitely.

#### Motions That Cannot Be Debated

- 1. To fix a time to adjourn, or to adjourn.
- 2. To object to the consideration of a question.
- 3. To table, or to take from the table.
- 4. To call for the previous question.
- 5. To limit or extend debate.
- 6. To withdraw a motion.
- 7. To suspend the rules.

#### Motions That Do Not Require a Second

- 1. To object to the consideration of a question.
- 2. To withdraw a motion.
- 3. To call for a division of the house.
- 4. Point of order.

#### Motions That Require a Two-Thirds Vote

# Fedrick C. Ingram Secretary-Treasurer, AFT, AFL-CIO Keynote Speaker, Saturday, May 18, 2024

Fedrick C. Ingram is secretary-treasurer of the AFT, serving 1.7 million members, including pre-K through 12th-grade teachers; paraprofessionals and other school-related personnel; higher education faculty and professional staff; federal, state and local government employees; and nurses and other healthcare professionals.

Ingram is the immediate past president of the 140,000-member Florida Education Association. He has served as an elected vice president of the AFT's executive council, and he served as an AFT vice president for six years (2014-2020) before being elected as the AFT's secretary-treasurer.

Since becoming secretary-treasurer in 2020, Ingram has amplified the voices of AFT members nationwide, particularly on education, labor and racial justice. President Joe Biden appointed him in April 2023 to the Presidential Advisory Commission on Advancing Educational Equity, Excellence, and Economic Opportunity for Black Americans.

Ingram serves on the executive committee of the AFL-CIO's Transportation Trades Department and on the board of Union Plus, a member benefits organization founded by the AFL-CIO. In June 2022, he was elected to serve as a vice president of the AFL-CIO's Union Label and Service Trades Department, which oversees a clearinghouse of public and private sector collective bargaining agreements. Earlier in 2022, he was elected to serve as a trustee on the board of the NAACP Foundation. In 2021, Ingram was elected to chair the AFL-CIO's Department for Professional Employees, a coalition of unions representing millions of professional and technical employees, including doctors, lawyers, engineers, teachers, actors and other highly trained workers.

Ingram grew up in inner-city Miami, where he attended public schools. Pursuing his love of music, he attended Bethune-Cookman University on scholarship and became the first member of his family to earn a postsecondary degree, in music education.

He would go on to become a music teacher and band director in Miami-Dade public schools for 10 years. Ingram is also an accomplished musician in his own right and has performed throughout the state and nationally as a saxophone soloist and conductor.

He was named the Francisco R. Walker Miami-Dade County Teacher of the Year in 2006, and in the same year was a finalist for the Florida Teacher of the Year award.

In 2013, he was elected president of the United Teachers of Dade, which represents employees of the fourth-largest school district in the nation. He held that post until 2015, when he was elected vice president of the Florida Education Association, where he became a bridge-builder and fearless advocate for public education, the joy of learning and the importance of the arts in education. In 2018, he won election as FEA president. Since then, he has been in frequent demand as a speaker, lecturer and presenter, and is recognized nationally for his workshops and presentations on community organizing and coalition building.

The Miami Herald's Legacy Miami magazine named Ingram as one of South Florida's 50 most powerful Black business leaders in 2013. He is a recipient of the prestigious JM Family African- American Achievers Award, given to leaders who have exemplified excellence in their fields.

In addition to his bachelor's degree from Bethune-Cookman, Ingram earned a master's degree in educational leadership from Barry University.

He also holds an honorary doctorate of humane letters from Florida Memorial University.


